Originally only the ones that had sailed the Bering Sea could join. In 1938

I was a boot seaman on the ARIADNE not knowing what to expect. Boy did I learn. It was cold up there and wet. There are not too many still around from the start of the Bering Sea meetings. I think it was in the early fifty's that Hurlin Hurt and Ohmer Raye got the first meeting started. They lived in Santa Cruz CA and that is where the group started. Beside myself, Jake Ridley is still going and Ralph Hackerson. I will miss seeing the group but know it will be a great gathering as usual."

**Dorothy Chiswell** – "Thanks so much for the news of the Reunion at Grand Haven, Michigan. I have lots of pleasant memories of Grand Haven when Capt. Ben was skipper of the MACKINAW. The ship always attended the Festival for a couple of days and the CO was treated like the Grand Marshall. We rode in the parade and attended all the festivities. It was really great. Son Ben III also served on the MACKINAW as his first assignment out of the Academy in 1966."

**Dan Baumbaugh** - One time, I found myself at Shemya waiting for fog to lift at Attu or Adak so that the UF2G - Albatross, in which I was traveling, could take off for one of those locations. There was a crippled MATS plane arriving from Japan with a full load of civilian dependants, with an with engine out and with an urgent need to land, fog or no fog, right away. I had the opportunity to be present in the GCA shack and watched the ground controller talk the plane down to a safe landing. I could see the blips on the radar's glide path and recall the controller telling the pilot where he was and whether to come right or left or up or down a bit. My heart was in my mouth as I watched this and I recall the controller telling the pilot that he was 25 feet above the end of the runway (I think Shemya had a very long, perhaps 10,000 feet runway) and that he should be seeing the runway visually.....right.....NOW! I glanced out of the window of the shack right at that moment and saw that big bird touch down through the heavy fog, right where the controller said he was, with a brief puff of smoke from the tires touching the concrete. Boy, from then on I was never again afraid of landing in an airplane even in bad weather. At least at places that had GCA facilities. Juneau airport, at that time, did not and

I was always nervous landing there in bad weather.
