The above weights are stripped (Naked). If an applicant weighs more than the normal weight, he will be accepted if the overweight is due entirely to muscle and bone, but not fat. Fat is cause for rejection.

MAJOR REQUIREMENTS FOR THE PHYSICAL EXAMINATION ARE AS FOLLOWS:

- (a) Height Not under 5'4" Barefooted and not over 6'2" barefooted if under 20 years of age. If over 20 years, NOT under 5'6" and not over 6'2".
- (b) Eyes to be free of infection and vision to be at least 20/30 in each eye uncorrected. Glasses are not permitted in taking eye tests.
- (c) Color Blindness is cause for rejection. (Ishara Plates" for testing color blindness are used.
- (d) Normal lungs and heart, without heart rurmurs.
- (e) Blood Pressure to be within normal limits for age.
- (f) No deformities or disfiguration of head, body or limbs.
- (g) Nose to be free of nasal obstructions.
- (h) Hernia (Rupture) disqualifies, provided it has not been successfully repaired by an operation.
- (i) TEETH: A minimum of 20 good teeth, four of which must be masticating in upper jaw opposing four masticating teeth in lower jaw, and three incisor teeth in upper jaw opposing three incisor teeth in lower jaw. Plates or bridgework are not acceptable in lieu of required natural teeth.
- (j) No swollen glands or inflamed tonsils.
- (k) No skin diseases or veneral diseases.
- (1) Weight and chest measurement according to height as shown in this pamphlet.
- (m) Operation for EMPYEMA (Pneumonia Drainage) is cause for rejection.
- (n) History of Syphilis.
- (o) Tuberculosis is cause for rejection.
- (p) Epilepsy, and sleep walking are causes for rejection.

ALSO: (1) A minimum of an eighth grade education is required, (2) no criminal record whatsoever, (3) Be a Citizen of the United States.

If after reading this you feel you are qualified fill out the application we are enclosing herewith and mail back to this office. Your application will then be investigated and you will be notified when to report in for physical examination, After physical examination, if successful in passing, you should be prepared to be assigned to immediate active duty.

Enlistments are for the duration of the war and six months and all original enlistments are effected in the rating of Apprentice Seaman for General Service. Pay Grades are as per following page



NOTE: An extra allowance of twenty (20) per cent is allowed for oversea duty on BASE PAY ONLY.
